

Pursuant to New York State Department of Health 405.4, any International Medical Graduate (IMG) enrolled in a medical school after 10/1/83 must have completed his clerkship, including “no more than 12 weeks of clinical clerkship in a country other than the country in which the medical school is located.” **Any IMG who completed more than 12 weeks of clinical clerkship outside of their medical school’s home country is NOT eligible for graduate medical training in New York State;** exceptions may be made only if approved by the New York State Education Department (please note the approved schools listed below).
